**YA Silver Card**

Last year YQ have changed the rules about the silver card. Having a silver card is optional however the YQ attitude is “anyone who wishes to partake in any sailing competition at any level must have a Silver Card”.

Silver card benefits include personal accident insurance and discounts on membership to magazines. At class, state and national championships skippers may be asked for a silver card number.

**Fees Due**

In accordance with the Constitution fees are due one month after the date of the Annual General Meeting. The Management Committee would appreciate all fees being paid by the beginning of the sailing season, i.e. the **SECOND SUNDAY in SEPTEMBER**. If any member is experiencing hardship, fees may be paid in two instalments. Please consult with the Secretary or Treasurer.

**Boat Storage Conditions**

Boats in storage on the grounds must be on a trailer that can easily be moved for the purpose of mowing the lawn. Boats must be left in an orderly condition and with all halyards secured to minimise wind noise and annoyance to neighbours. Storage sites are declared vacant at the end of each sailing season and sites allocated on acceptance and receipt of membership and storage fees. All boats are stored at the owners risk and the club accepts no liability for loss or damage.

**Special discount on boat storage fee** - the boat storage fee is **\$730** per annum; however **\$365** will be refunded on participating in **racing for at least 12 weekends** during the season. For members who have sailed regularly the previous season the discounted amount of **\$365** (being \$730 less the refund of \$365) may be available at the start of the season.
